

CDP Announces New Ownership, Executive Promotions

April 1, 2024 (Chicago, Illinois) – Custom Data Processing, Inc. (CDP), provider of electronic health solutions and electronic benefit transfer (EBT) processing services, has announced several staffing changes, effective immediately.

CDP President, Steve Marston, has stepped back and will retire, effective June 30, 2024. He has been with CDP since 1981 and was one of the company's first six employees. He has served as both a Project and Account Manager for environmental health, electronic health records, and WIC EBT. In 2016, he was promoted to Vice President, where he has overseen Business Development, as well as contract management.

Joseph Gilland has been promoted to Interim Vice President of Technology. In this role, he will be responsible for setting the technology strategy for the company.

Joseph joined CDP in 2007 as a senior software developer and played an integral part in the creation of WIC Direct before serving as the Product Owner from 2011 through 2022. He then transitioned to be the Director of DevOps and Technology Strategy.

Other promotions include:

- Bonnie Lozada, who has been the Human Resources Specialist since 2017, will now serve as the Director of Human Resources.
- Michelle Craven, a nine-year CDP veteran, will now serve as the Accounting Manager.
- Chris Davis, Director of Network Operations, who has been with the company since 2008, will
 expand his role to oversee the Network Operations, Network Services, and Database
 Administration teams.

CEO Stan Cochran is ready to move forward with the new executives. "All of these promotions are well deserved and place our company in strong hands for the future."
